401 Madison St., Shillington Borough (CM-06-00303): Arthur Turaj. Floodway Encroachment. Mr. Turaj's restoration plan has been approved by DEP, and he has initiated the restoration work.

102/105 Enforcement and Potential Enforcement Actions Continued

Bollinger Road/341 Hickory Road, Marion Twp (CM-06-00600) (Preserved Farm): On June 5, 2024, the BCCD approved the restoration plan. The restoration work will occur between October 2024 and February 2025 to avoid disturbing an adjacent bald eagle nest.

581 Airport Road, Bethel Twp (CM-06-00647): Matthew Hassler, Hassler Excavating. Mr. Hassler is a repeat offender per DEP. The District cited him for filling wetlands without a permit on an adjacent site. Mr. Hassler then proceeded to disturb earth, fill wetlands, and watercourses without permits. A pre-enforcement meeting will be held on the site with DEP on June 25, 2024.

201 Forge Dam Road Driveway Improvements, Upper Bern Twp (ESP-06-02638) PAC060348: Michael Piepoli, 299 MSS, LLC. A Corrective Action Plan (CAP) has been submitted for Chapter 102 permit violations on June 17, 2024. Furthermore, the BCCD recuperated \$2,057 in expenses paid by 299 MSS, LLC for the CAP.

170 N. Bingaman Street Exeter Twp/St. Lawrence Borough (CM-06-00399): Un-permitted Stream Obstruction/Bridge Installation. 4/12/2024: The DEP, District, and responsible parties (Mr. Coulter and Mr. Lerch) are scheduling a conference call to discuss the current site situation. Additionally, DEP and the District will outline the proper steps that the responsible parties need to take for the site to comply and obtain proper permitting for the activity. 5/2/2024: A Meeting was held with DEP, the District and responsible parties. It was decided that Mr. Coulter will need to start talking to a consulting firm about designing a bridge and compiling an application to submit for the proper permitting for the bridge by the week of June 3rd, 2024.

Green Hills Estates, Robeson (PAD060075): 5/1/2024: A pre-construction meeting was held at the project site with DEP, the District, the Applicant and the Co-permittee for the new individual permit that was issued for the continuation and completion of the project. Erosion and Sediment control violations were observed during a walkthrough of the site with all personnel that attended the meeting. The District will continue to monitor the site and ensure that any violations are corrected before the project starts earth moving and construction again. The DEP will be copied and notified of any inspection reports and updates on the site.

Bollinger Road/341 Hickory Road, Marion Twp (CM-06-00600) (Preserved Farm): Marion Township has submitted the restoration plan. The BCCD has issued a deficiency letter.

Briarwood Subdivision, South Heidelberg Twp, Walter Greth, Greth Homes: Mr. Greth has two permits that were not terminated and PCSM BMPs that require repair. DEP has decided not to pursue enforcement against Mr. Greth.

Lyons Solar (PAD060068): The solar panels and PCSM BMPs have been installed; however, the site is not permanently stabilized. The amended soils and permanent seeding have occurred, but the site is still achieving permanent stabilization. The PCSM BMPs are still being converted to their permanent conditions. Due to the continued issues that have occurred, the District has sent an enforcement referral to DEP. A site meeting is scheduled to take place on Thursday, June 20th, Commissioner Leinbach and the Conservation District are hosting the meeting and are including the affected landowners, local officials and agencies, State Senators/Representatives, Lyons Solar officials (Heelstone), officials from DEP and Dept of Ag. There will be no media invited to the meeting.
